A RESOLUTION of the Board of Commissioners of Public Hospital District, Point Roberts, Washington regarding:

Approval of an increase of percentage of levy for the 2024 budget year.

BE IT RESOLVED BY the Board of Commissioners of Public Hospital District, Point Roberts, Washington that:

Whereas, the Board of Commissioners of Point Roberts Public Hospital Taxing District, after hearing and after duly considering all relevant evidence and testimony presented, determined that Point Roberts Public Hospital Taxing District requires an increase in property tax revenue from the previous year, in addition to that resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, in order to discharge the expected expenses and obligations of the district and in its best interest; now therefore, be it Resolved, by the Board of Commissioners of the Point Roberts Public Hospital Taxing District that an increase in the regular property tax levy, in addition to the increase resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, is hereby authorized for the 2024 levy in the amount of \$2881.20, which is a percentage increase of 1 percent from the previous year.
