Please describe your occupation (or former occupation if retired), qualifications, professional and/or community activities, and education	I am a senior organizer with Community First Whatcom, running issue campaigns at the city and county level, often with a focus on housing equity. I am intimately familiar with many of the issues facing our communities as I spend a lot of time speaking with community members about their issues, door to door canvassing, and attending and running listening sessions. I have also personally experienced housing insecurity in Whatcom County as a young queer person. I have a strong background in organized labor, having worked for SEIU 1199nw at PeaceHealth

St. Joseph's Medical Center, and serving as a bargaining committee member for Western Academic Workers United.

My educational background is in history. I received my Bachelor's Degree in History from Washington State University in 2021, and have completed all the classwork for a Master's Degree in History from Western Washington University.

8. Please describe why you're interested in serving on this Advisory Group.

As a historian, a housing advocate, and an ally of organized labor, I know that the way we carve up spaces has deep impacts on people's lives, the local environment, and the way our community functions. Having a planning commission that integrates the expertise of builders, developers, environmental, and agricultural advocates is a crucial part of getting expert recommendations, but the commission should also have a member whose expertise lies in how those changes affect everyday people. I spend much of my time advocating for people who are being left behind by current housing and land use policy developments. Those people should have a representative on the planning commission who evaluates how comprehensive plan amendments will impact their access to housing on the ground level, the manner in which the way we carve up land for development affects their ability to access their workplaces, and who advocates for an ample natural environment that keeps people healthy.

In addition, I want to advocate for the needs of younger residents and students. I have strong connections with on-campus organizations, and I have a lot of younger residents in my circle who are struggling to meet their everyday needs, through no fault of their own. Younger residents don't have much of a voice in Whatcom, since they have had less time to get grounded in the community, and are largely not yet a part of the county's business landscape. They deserve someone advocating for their spatial, housing, and economic needs on one of the most important commissions in the county.
