**PUBLIC HEARING NOTICES**


Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its February 12, 2019, meeting, or at a later date: **ORDINANCE REGARDING TEMPORARY INSTALLATION OF STOP SIGNS ON CERTAIN COUNTY ROADS (AB2019-073):** This ordinance authorizes the installation of temporary stop signs on Harborview Road, Shintaffer Road, Cottonwood Drive, and Birch Bay Drive, until the road repairs for erosion are completed. **ORDINANCE ESTABLISHING A TEMPORARY SPEED LIMIT CHANGE FOR BIRCH BAY DRIVE (AB2019-074):** This ordinance authorizes Public Works to temporarily lower the speed limit on Birch Bay Drive, from the intersection of Harborview Road to 300 feet past the intersection of Cottonwood Drive, to 10 MPH due to the special hazard of erosion to the southbound lane, until the road repairs are completed. **ORDINANCE ESTABLISHING TEMPORARY ONE-WAY TRAFFIC ON BIRCH BAY DRIVE (AB2019-075):** This ordinance authorizes Public Works to temporarily establish a one-way traffic pattern on Birch Bay Drive, from the intersection of Harborview Road to the intersection of Shintaffer Road, due to the erosion to the southbound lane, until the road repairs are completed. **ORDINANCE AUTHORIZING THE TEMPORARY RE-OPENING OF COTTONWOOD DRIVE AT MORGAN DRIVE TO VEHICULAR TRAFFIC (AB2019-076):** This ordinance authorizes Public Works to re-open Cottonwood Drive at Morgan Drive to northeast bound vehicular traffic until the road repairs for erosion of Birch Bay Drive are completed. **ORDINANCE ADOPTING VARIOUS MINOR AMENDMENTS TO WHATCOM COUNTY CODE TITLES 20 (ZONING), 21 (LAND DIVISION REGULATIONS), AND 22 (LAND USE AND DEVELOPMENT PROCEDURES), MAKING CORRECTIONS, UPDATES, AND CLARIFICATIONS (AB2019-018):** This ordinance adopts minor amendments to WCC Title 20 (Zoning), 21 (Land Division Regulations), and 22 (Land Use and Development Procedures) to add clarity to development regulations and procedures, and to fix inconsistencies and grammar.

Council introduced the above at its January 29 meeting. Public documents are available for review in the



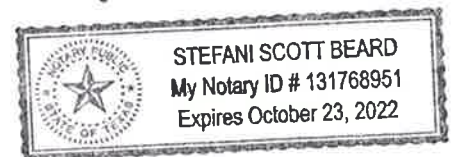
