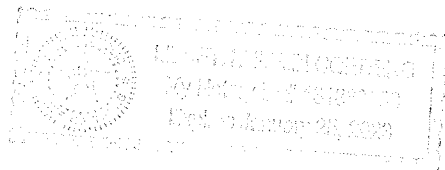

A property tax increase in addition to the amount resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property is hereby authorized for the 2020 levy in the amount of \$0, which is a percentage increase of 0% from the previous year. and complete prior to the effective date of this ordinance and vested pursuant to Washington statutes; 2. Were for building permits for remodels, maintenance, or repairs of existing structures where no increased capacity for shipping unrefined fossil fuels not to be processed at Cherry Point will result; 3. Were necessary to protect health and safety of the community. This interim ordinance shall be effective for not longer than six months following its effective date, but may be renewed for one or more six-month periods if subsequent public hearings are held and findings of fact are made prior to each renewal. This ordinance was introduced November 19, 2019.

**ORDINANCE LIMITING 2020 PROPERTY TAX LEVY (AB2019-606):** This ordinance limits the amounts collected through the County general levy to the amount of 2019 taxes, increased for the addition of new construction and improvements to property and any increase in the value of state-assessed property. A property tax increase in addition to the amount resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property is hereby authorized for the 2020 levy in the amount of \$300,000, which is no more than a 1% increase from the previous year. This ordinance was introduced November 19, 2019.
