### COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its April 9, 2019, meeting: **ORDINANCE (2019-028) AMENDING WHATCOM COUNTY CODE SECTION 1.14, ELECTORAL PRECINCTS, FOR CHANGES IN CERTAIN VOTING PRECINCT BOUNDARIES IN WHATCOM COUNTY (AB2019-183):** This ordinance adopts and substitutes into the "Book of Election Precinct Maps" referred to in Whatcom County Code Section 1.14, changes affecting precincts #118, 611, 144, 607, 201 & 202. The revised "Book of Election Precinct Maps" is available through the Whatcom County Council Office and online through the Election page at the Whatcom County Auditor's Office homepage.

**ORDINANCE (2019-029) INCREASING THE FERRY SYSTEM PETTY CASH REVOLVING FUND FROM \$1800 TO \$3300 (AB2019-176):** This ordinance authorizes the increase in the Ferry System Petty Cash Fund to \$3300.

**ORDINANCE (2019-030) AMENDING PROJECT BUDGET NO. 2 (EAST WHATCOM REGIONAL RESOURCE CENTER) AS ESTABLISHED THROUGH ORDINANCE 2008-025, EIGHTH REQUEST, IN THE AMOUNT OF \$115,000 FOR A PROJECT BUDGET OF \$6,212,571 (AB2019-184):** This ordinance adds \$15,000 in expenditure authority to the original project budget for a total amended project budget of \$6,212,571.

**ORDINANCE (2019-031) AMENDING WHATCOM COUNTY CODE CHAPTER 2.128, BUSINESS AND COMMERCE ADVISORY COMMITTEE TO REVISE MEMBERSHIP (AB2019-187):** This ordinance revises the committee membership to add one additional member to serve as a representative from the health care industry and one additional member representing for-profit entities in any industry. Council introduced the above at its March 26 meeting. Public documents are available for review in the Council Office, 311 Grand Avenue, Bellingham. Meetings are in the Council Chambers, same address, at 7:00 p.m., unless otherwise announced.



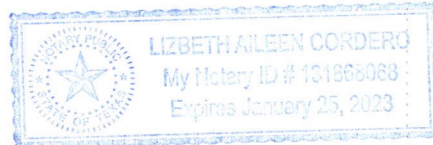


