Enclosed are two (2) originals of an Amendment renewing the contract between Whatcom County and Northwest Regional Council (NWRC) for your review and signature.

Background and Purpose

NWRC was awarded the bid for Nursing Services via the RFP process in 2019. They have provided us with Nursing Services since December of 2013. Included in the Contract are the Main Jail, the Work Center and Juvenile Detention.

Funding Amount and Source

Funding for the Jail and Work Center will come from the 2024 Corrections Bureau budget with a maximum annual compensation of \$1,882,935.06 (\$86.55 per hour, 21,755.46 hours). Juvenile Detention's funding will come from their budget with a maximum annual compensation of \$41,616.00 (\$3,468.00 per month). The total combined annual compensation will not exceed \$1,924,551.06.

Differences from Previous Contract

This is an increase of \$100,431.06 for the Jail and Work Center.

Amendment No. 6 Whatcom County Contract No. 201911036 CONTRACT BETWEEN WHATCOM COUNTY AND NORTHWEST REGIONAL COUNCIL (NWRC)

THIS AMENDMENT is to the Contract between Whatcom County and Northwest Regional Council (NWRC), dated November 26, 2019 and designated "Whatcom County Contract No. 201911036". In consideration of the mutual benefits to be derived, the parties agree to the following:

This Amendment decreases the number of hours worked for Nursing Services in the Jail and Work Center from 22,050 to 21,755.46 and increases the hourly rate from \$80.84 to \$86.55 (7.06 % increase). This increases the maximum annual compensation by \$100,431.06 for a total of \$1,882,935.06. Juvenile Detention's annual amount of \$41,616.00 will remain the same bringing the combined annual total consideration for the Jail, Work Center and Juvenile to \$1,924,551.06.

This brings the total not-to-exceed contract amount for the period January 1, 2020 through December 31, 2024 to \$8,357,536.17.

This amendment also changes NWRC's Executive Director from Dan Murphy to Amanda McDade and changes the County's Administrative Officer from Chief Wendy Jones to Chief Caleb Erickson.

Unless specifically amended by this agreement, all other terms and conditions of the original Contract and any other Amendments shall remain in full force and effect.

This Amendment takes effect: January 1, 2024 regardless of the date of signature and expires December 31, 2024.
