INCREASE OF REAL PROPERTY TAX LEVY

WHEREAS, the Commissioners of Whatcom County Fire District #11 have properly given notice of the public hearing held November 10th, 2020 to consider Whatcom County Fire District #11's current expense budget for the 2021 calendar year, pursuant to RCW 84.55.120.

Amount levied in proceeding year: \$365,598.47

WHEREAS, the Board of Commissioners of Whatcom County Fire Protection District # 11, Taxing District, after hearing and after duly considering all relevant evidence and testimony presented, determined that Whatcom County Fire Protection District # 11 Taxing District requires an increase in property tax revenue from the previous year, in addition to that resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, in order to discharge the expected expenses and obligations of the district and in its best interest;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Whatcom County Fire Protection District #11 Taxing District, that an increase in the real property tax levy, in addition to the increase resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, is hereby authorized for the 2021 levy in the amount of \$1,871.35 which is a percentage increase of 1% from the previous year.
