Whatcom County Council will have a public hearing, will consider adopting, and may amend the following at its August 9, 2022 meeting, 6PM meeting, or at a later date:

ORDINANCE GRANTING CASCADE NATURAL GAS CORPORATION A NON-EXCLUSIVE FRANCHISE TO OPERATE AND MAINTAIN A NATURAL GAS PIPELINE SYSTEM WITHIN WHATCOM COUNTY. (AB2022-380)

This ordinance grants a non-exclusive seven (7) year franchise to construct, operate, maintain, remove, replace and repair new or existing pipeline facilities, together with equipment and appurtenances thereto, for the transportation of natural gas within and through Whatcom County, Washington. Council introduced the above at its July 12, 2022 meeting.

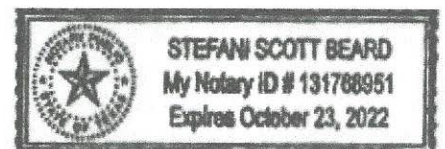
