General Terms and Conditions Agreement

Attached is an Interlocal Agreement between Whatcom County and Washington State Department of Social & Health Services (DSHS) Developmental Disabilities Administration (DDA) for your review and signature.

#### Background and Purpose

This Agreement states the General Terms and Conditions that govern work to be performed under any program agreement between DSHS and Whatcom County. These General Terms and Conditions are used to mitigate risk to DSHS and establish the scope of work and other details determined by the various DSHS administrations. Because the General Terms are developed and managed by a central office in DSHS (Central Contracts and Legal Services), requests made to change those terms often delay executed new agreements because of the additional administrative approvals and work required, should a request be made. DSHS executes this General Terms and Conditions Agreement at regularly scheduled intervals rather than at the time a new contract for actual goods and services is being negotiated between DSHS and Local Health Jurisdictions (LHJ). Having pre-established General Terms and Conditions that are uniform helps to streamline the contract process and fosters a more efficient and manageable delivery of services to clients. Upon execution, these General Terms and Conditions will serve to govern individual Program Agreements between LHJs and DSHS.

	information within one business day (previously 5 or 3) of discovery.
11. E-Signature and Records	Adds section indicating that an electronic signature or electronic record of
	this agreement or any other ancillary agreement shall have the same legal
	effect as delivery of an original executed copy for all purposes.
