Subsidy Update

What was:

WA State Subsidy increase from 0-60% to 75% SMI

WCHCS Local Subsidy Recommendation 75%-85% SMI +

Rate Augmentation for providers serving kids 0-3 on Working Connections Child Care (WCCC)

State Funded Pre-K Programs Growing

What is:

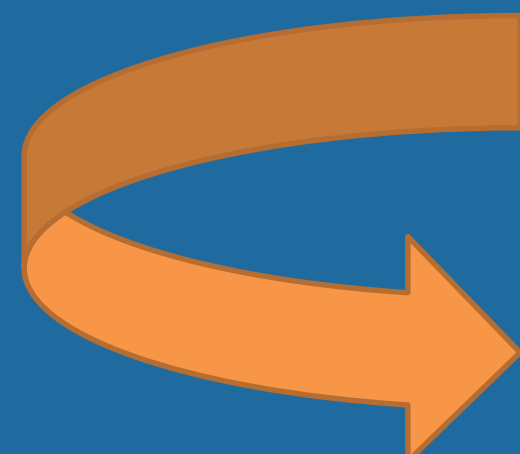
WA State Subsidy remained at 0-60%

Drastic Cuts to State Funded Pre-K Programs and Early Learning

What is recommended moving forward:

Subsidy 60%-75% SMI

Rate Augmentation 0-5 for Child Care Providers serving Children on WCCC

Original Recommendation

Activity	Yearly Cost	Number of Children Served + 20% Uptake
Tuition Discount to families at \$300 per month children age 0-5 at 61%-75% of SMI	\$1,434,960	400
Rate Augmentation to providers at \$300 serving kids 0-3	\$1,821,600	506
TOTAL	\$3,256,560	906

Final Recommendation

Activity	Yearly Cost	Number of Children Currently Served
Tuition Discount to families at \$300 per month children age 0-5 at 61%-75% of SMI	\$1,434,960	400
Rate Augmentation to providers at \$300 (0-1), \$200 (2-3) and \$100 (3-5) per month for each enrolled WCCC	\$1,920,000	1007
TOTAL	\$3,354,960	1407
