I'm retired from a career in wildlife/nature education. Most of my career, I was employed by the Colorado Division of Wildlife (now Wildlife & Parks), though I have also worked for the U.S. Forest Service and the U.S. Army Corps of Engineers (as well as other). A portion of my college education was completed at Oregon State University, where I learned about the ecology of the Pacific Northwest. In addition, I completed the "Marine Naturalist Certification" program offered by the Whale Museum in Friday Harbor, which foccussed on the ecology of the Salish Sea. While a public employee with the state of Colorado, I held three different positions - each was primarily public education/information & interpretation about wildlife. As an educator/interpretive specialist, I was required to understand wildlife biology, habitat / ecology, wildlife - human interface challenges, hunting & wildlife disease issues etc., AND to be able to communicate thoughtfully & effectively with the public. My career was devoted to helping people better understand wildlife, wildlife management, and ecosystems & our role in them. The opportunities I was afforded in these positions were amazing and diverse. My degree is in natural resources/environmental communication. But my experiences in my career allowed me to work beside wildlife biologists & game wardens. I ran a nature center. Taught numerous classes. Helped release bears and picked up dead ducks from out of the city park - and came up with ways to improve the water there. I taught bird watching, interpreted habitat improvement, helped lead public input meetings, produced interpretive signs and informative brochures re: Living With Wildlife; supervised volunteers; and contributed to books on designing positive wildlife viewing experiences. I am happy to provide additional information if desired.

A neighbor approached me about joining this committee, and asked me to apply. In my community of Sudden Valley, I have lead a group I named "Sudden Valley Naturalists." The "group" is a loose group of residents interested in learning more about our natural world; and I've taught a couple of classes here, including birding, intro to botany & "living with wildlife." I remain VERY interested in wildlife, learning, and wildlife/people issues. As an educator, I was required to learn about a broad diversity of subjects. I would love to find a way to contribute to my community - my county - by offering any experience, knowledge, insight I may have - not only to issues, but to communicating about them.
