### Background and Purpose

The RALJ appeals are cases where clients who have been convicted in District Court on misdemeanor charges request to appeal the District Court decision up to the Superior Court level. We currently have 5 cases already being handled by Stephen Jackson Law, PLLC, but we propose to add two more cases this month and we project three more appeals will be filed by the end of 2023 for a possible total of 10 cases.
