Please describe your occupation (or former occupation if retired), qualifications, professional and/or community activities, and education	I was a staff person and consultant to Lummi Island Heritage Trust, a land conservation trust, from 1997 to 2007, serving as the organization's second executive director. My work experience included negotiating and drafting conservation easements; securing state and federal grants for land conservation projects; partnering with the Department of Fish and Wildlife to protect high priority properties; and educating the public about the benefits of conservation easements. More recently, I served two terms (early 2018 through 2022) on the County's Climate Impact Advisory Committee, co-authoring a research report to the committee and coordinating the committee's public review process for the 2019 Climate Action Plan. I studied

geography as an undergraduate, with a minor in conservation and resource studies,

and have a master's degree in natural resource policy and administration. My course work included forestry, agricultural policy, forest hydrology, natural resources conflict resolution, negotiation skills, and natural resource policy. I have worked on my brother's 70 acre farm on Lummi Island, where he raises beef cattle and chickens. I own a 47 acre property on Lummi Island that is protected with a working lands conservation easement.

8. Please describe why you're interested in serving on this Advisory Group.

I see protection of working lands and priority ecosystems as critical to achieving the County's climate protection and climate adaptation goals. I would like to help ensure that the Conservation Easement Program is maximizing its community benefits and doing all it can to preserve our quality of life here in Whatcom County.
