ACTION TAKEN

The Whatcom County Council adopted the following at its March 22, 2022 meeting: **ORDINANCE (2022-022) CHANGING THE NAME OF BEAR TRAP ROAD TO BEAR SPIRIT ROAD (AB2022-136)** This ordinance changes the name of Bear Trap Road to Bear Spirit Road, located within Section 13, Township 40 North, Range 1 West, W.M. Stop signs to be removed once road repairs are completed. Ordinance introduced March 8, 2022. **ORDINANCE (2022-023) FOR TEMPORARY INSTALLATION OF A STOP SIGN ON DRAYTON HARBOR ROAD (AB2022-137)** This ordinance allows for the installation of a temporary stop sign on Drayton Harbor Road, eastbound, 320 feet westerly of Shintaffer Road, located within Section 13, Township 40 North, Range 1 West, W.M. Stop sign to be removed once road repairs are completed. Ordinance introduced March 8, 2022. **ORDINANCE (2022-024) FOR TEMPORARY INSTALLATION OF STOP SIGNS ON SOUTH PASS ROAD (AB2022-138)** This ordinance allows for the installation of temporary stop signs on South Pass Road, eastbound, 707 feet easterly of North Pass Road, 17 and westbound, 1010 feet easterly of North Pass Road, located within Section 26, Township 40 North, Range 4 East, W.M. Stop signs to be removed once road repairs are completed. Ordinance introduced March 8, 2022. **ORDINANCE (2022-025) REPEALING ORDINANCE 2022-005, TEMPORARY CLOSURE OF GULF ROAD (AB2022-156)** This ordinance repeals Ordinance 2022-005, which ordered the temporary closure of a portion of Gulf Road. Ordinance introduced March 8, 2022. **ORDINANCE (2022-026) AMENDING THE 2022 WHATCOM COUNTY BUDGET, REQUEST NO. 6, IN THE AMOUNT OF \$1,393,462 (AB2022-153)** This ordinance amends the 2022 Whatcom County Budget as follows: From the General Fund: reappropriate \$250,000 in Non Departmental to fund Opportunity Council Microenterprise Assistance Program from CDBG grant proceeds; reappropriate \$32,565 in Non Departmental to fund What-Comm E911 operations from State Military Department grant proceeds; appropriate \$11,697 in Parks to fund plant materials, supplies and contracted maintenance at Hovander Homestead Park from donations; appropriate \$345,686 in Parks to fund repairs at Hovander Homestead Park and Fragrance Garden caused by November 2021 flood; appropriate \$12,000 in Planning & Development Services to fund vehicle maintenance expense due to theft; reappropriate \$100,000 in Planning & Development Services to fund Offsite Buffer Mitigation Program Feasibility Study; appropriate \$13,700 in Sheriff to fund LOKI Mk2 drone system; appropriate \$26,983 in Sheriff to fund less lethal launcher components; appropriate \$13,979 in Sheriff to fund recreational boating safety program from grant proceeds. From the Road Fund: appropriate \$175,000 to fund transfer in support of Truck Road emergency bank stabilization project. From the Veterans' Relief Fund: appropriate \$101,352 to fund contracted Veteran Service Officer. From the Parks Special Revenue Fund: appropriate \$170,500 to fund Birch Bay Beach Park improvements. From the Ferry Fare Capital Surcharge Fund: appropriate \$30,000 to fund FSE terminal electrification study. From the Public Utilities Improvement Fund: appropriate \$110,000 to fund Lottie Street remodel. Ordinance introduced March 8, 2022. **RESOLUTION (2022-014) AMENDING THE FLOOD CONTROL ZONE DISTRICT & SUBZONES 2022 BUDGET, REQUEST NO. 1, IN THE AMOUNT OF \$1,421,000 (COUNCIL ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2022-152)** This resolution amends the Flood Control Zone District & Subzones 2022 budget as follows: From the Flood Control Zone District Fund: appropriate \$1,400,000 in River & Flood to fund Truck Road emergency bank stabilization project from grant proceeds and Flood and Road Fund balances; appropriate \$21,000 in Natural Resources to fund 2022 PIC agricultural cost share. Resolution introduced March 8, 2022. **ORDINANCE (2022-027) AMENDING WHATCOM COUNTY CODE CHAPTER 2.02 (COUNTY COUNCIL) TO DEFINE ABSENCE AND TEMPORARY DISABILITY (AB2021-594)** This ordinance amends Whatcom County Code Chapter 2.02 (County Council) to define absence and temporary disability as it relates to the Executive Pro Tempore serving in place of the Executive. Ordinance introduced October 26, 2021.

The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on April 12, 2022, or at a later date: **RESOLUTION VACATING A PORTION OF HORTON ROAD (AB2022-121)** Petitioners seek to vacate the county's legal rights to open the road or portion of a road described as follows: All that portion of Horton Road as dedicated on Bakerview Addition to the City of Bellingham, filed for record February 26, 1938, and recorded in Volume 7 of Plats, Pages 40 through 45, records of Whatcom County, Washington, more particularly described as follows: All that portion of said Horton Road lying between the east right of way margin of Boxwood Road, as dedicated on said Bakerview Addition Plat and the east line of Blocks 86 and 87 extended of, said Bakerview Addition Plat. Situate in Whatcom County, Washington. Resolution introduced February 22, 2022. **RESOLUTION VACATING A PORTION OF BOXWOOD ROAD (AB2022-122)** Petitioners seek to vacate the county's legal rights to open the road or portion of a road described as follows: All that portion of Boxwood Road as dedicated on Bakerview Addition to the City of Bellingham, filed for record February 26, 1938, and recorded in Volume 7 of Plats, Pages 40 through 45, records of Whatcom County, Washington, more particularly described as follows: All that portion of said Boxwood Road lying between the south right of way margin of Horton Road, as dedicated on said Bakerview Addition Plat and the north right of way margin of Thomas Road, as dedicated on said Bakerview Addition Plat. Situate in Whatcom County, Washington. Resolution introduced February 22, 2022. **ORDINANCE ESTABLISHING MOVEMENT RESTRICTIONS ON E. HEMMI ROAD AT THE INTERSECTION WITH HANNEGAN ROAD (AB2022-162)** This establishes movement restrictions on Hemmi Road at the intersection with Hannegan Road as follows: 1) Left Turns shall be prohibited from westbound E. Hemmi Road to southbound Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M. 2) Through Movements shall be prohibited from westbound E. Hemmi Road to westbound E. Hemmi Road at the intersection with Hannegan Road from 8:30 am to 10:30 am and 3:00 pm to 4:30 pm, during the school year, located in Sections 16, 17, 20 and 21, Township 39 North, Range 3 East, W.M. Ordinance introduced March 22, 2022. **ORDINANCE REMOVING A SCHOOL SPEED ZONE ON HANNEGAN ROAD (AB2022-163)** This ordinance removes the school speed zone on Hannegan Road from 500 feet north of Ten Mile Road to E. Hemmi 33 Road in Sections 16 and 17, Township 39 North, Range 3 East, W.M. Ordinance introduced March 22, 2022. **ORDINANCE ESTABLISHING PARKING CONTROL ON EDDIE LANE WITHIN THE PLAT OF WHISPER LAKE (AB2022-164)** This ordinance establishes a No Parking Anytime zone on the north side of Eddie Lane from SR-548/Blaine Road westerly to the cul-de-sac, located within Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. **ORDINANCE ESTABLISHING A SPEED LIMIT WITHIN THE PLAT OF WHISPER LAKE (AB2022-165)** This ordinance establishes a 25 mile per hour speed limit on all roads within the plat of Whisper Lake, located in Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. **ORDINANCE FOR INSTALLATION OF A STOP SIGN WITHIN THE PLAT OF WHISPER LAKE (AB2022-166)** This ordinance establishes a new stop sign on Eastbound Eddie Lane at the intersection of SR-548/Blaine Road within Section 31, Township 40 North, Range 1 East, W.M. Ordinance introduced March 22, 2022. **ORDINANCE AMENDING WHATCOM COUNTY CODE SECTION 1.14, ELECTORAL PRECINCTS, ADJUSTING BOUNDARY LINES BASED ON DECENNIAL CENSUS INFORMATION IN THE LEGISLATIVE, CONGRESSIONAL AND COUNTY COUNCIL DISTRICTS (AB2022-177)** This ordinance replaces Whatcom County Code Section 1.14 with newly established voting precinct boundaries and substitutes the same into the "Book of Election Precinct Maps" available through the Whatcom County Council Office, the Whatcom Auditor's Office, and online. Ordinance introduced March 22, 2022.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on April 12, 2022, or at a later date: **ORDINANCE AMENDING WHATCOM COUNTY CODE 2.21, BOARD OF EQUALIZATION (AB2022-190)** This ordinance will amend Whatcom County Code 2.21, Board of Equalization, to add two alternate members to the board. Ordinance introduced March 22, 2022.

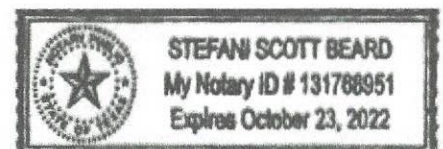
