NOTICE IS HEREBY GIVEN that a public hearing will be held by the Whatcom County Council on Wednesday, August 5, 2020 at 6:00 p.m., or at a later date (AB2020-330). The purpose of the public hearing is to review community development and housing needs, inform citizens of the availability of funds and eligible uses of the state Community Development Block Grant (CDBG), and receive comments on proposed activities, particularly from lower income persons residing in Whatcom County. Up to approximately \$500,000 may be available to Whatcom County, to fund CDBG public services and emergency response, or temporary housing facilities that address COVID-19 impacts. All CDBG funded activities must benefit low- and moderate-income persons or meet the CDBG urgent need national objective criteria. An overview of the proposed activities will be available for review at the County Executive office at Suite 108, 311 Grand Avenue, Bellingham by 11:00 am on August 11, 2020. Comments may also be submitted in writing to the Whatcom County Council until the public hearing has been closed. The Council is currently holding all meetings remotely.
