The Whatcom County Council adopted the following at its August 8, 2023, meeting: ORDINANCE (2023-046) ESTABLISHING A TEMPORARY CLOSURE OF WEST SMITH ROAD FROM NORTH-WEST DRIVE TO THE FERNDALE CITY LIMITS (AB2023-471): This ordinance temporarily closes West Smith Road from North-west Drive to the Ferndale City limits in order to complete the decommissioning of a sewer fine pump station. This ordinance was introduced on July 25, 2023. ORDINANCE (2023-047) AMENDING THE 2023 WHATCOM COUNTY BUDGET, REQUEST NO. 11, IN THE AMOUNT OF \$250,000 (AB2023-470): This ordinance amends the 2023 Whatcom County Budget to appropriate \$250,000 from the Ferry Fare Capital Surcharge Fund to fund Ferry Replacement Capital Contributions, #1 companion to Supplemental #4037. The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on September 12, 2023, or at a later date: ORDINANCE ESTABLISHING PARKING RESTRICTIONS ON EUCLID AVENUE AS WHATCOM COUNTY CODE 10.24.260 (AB2023-526): This ordinance amends Whatcom County Code 10.24.260 to establish a "No Parking" Zone on Euclid Avenue from 10.00 p.m. to 6:00 a.m. on the east do of Louid Avenue from approximately 735 feet south of Crescent Street at the north to Glen Cove Lane to the south. This ordinance was introduced on August 8, 2023. ORDINANCE ESTABLISHING PARKING RESTRICTIONS ON ALDRICH ROAD AS WHATCOM COUNTY CODE 10.24.265 (AB2023-528): This ordinance establishes a "No Parking" zone on both sides of Aldrich Road from the southerly intersection of the Right-of-Way of Waldron Road to the Bellingham City Limits. This ordinance was introduced on August 8, 2023. ORDINANCE ADOPTING VARIOUS AMENDMENTS TO WHATCOM COUNTY CODE TITLE 20, ZONING, REGARDING HOME-BASED BUSINESSES (RE2023-399): This ordinance amends Whatcom County Title 20, Zoning consolidate existing regulations for home occupations, cottage industries, and occasional comercial use of noncommercial properties for hosting special events. This ordinance was introduced on August 8, 2023. ORDINANCE ESTABLISHING PARKING RESTRICTIONS ON SAMISH WAY (AB2023-501): This ordinance establishes a "No Parking" zone on Samish Way, 500 feet east of Galbraith Lane and 500 feet west of Galbraith Lane on the south side of the road. ORDINANCE AMENDING THE 2023 WHATCOM COUNTY BUDGET, REQUEST NO. 12, IN THE AMOUNT OF \$2,126,139 (AB2023-509): This ordinance amends the 2023 Whatcom County Budget as follows: From the General Fund – appropriate \$49,550 in Non-Departmental to fund What-Comm E911 Ops 2023-24 from grant proceeds; appropriate \$52,950 in Planning and Development Services to fund Comprehensive Plan Update from grant proceeds; appropriate \$54,675 in Parks and Recreation to fund replacement of Semiahmoo Park Interpretive Sign; appropriate \$41,997 in Health to fund Opioid Program Specialist position from grant proceeds; appropriate \$33,997 in Health to fund Human Services labor pool adjustment (companion to Supplemental #4045 Opioid Program Specialist position); record operating transfer of \$8,499 to the General Fund in Health (companion supplemental #4052 New Community Health Assistant Manager position; appropriate \$33,836 in Health to fund companion supplemental #4052 New Community Health Assistant Manager position; appropriate \$31,636 in Health to fund companion supplementals #4052, #4053, #4054, #4055, #4056 funding Community Health Assistant Manager position; record \$6,328 in Health to fund Human Services labor pool adjustment, companion supplementals \$14,070 in Sheriff to fund increase for two rescue boats. From the Veterans Relief Fund – appropriate \$34,050 in the Jail Fund – appropriate \$34,050 in Health for fund companion supplementals # AB2023
