Please find attached for your review a copy of the grant agreement between the Whatcom County Flood Control Zone District and the State of Washington Department of Ecology (Department of Ecology) for funding Adjudication Technical Assistance. #### **Requested Action**

Public Works respectfully requests that the Flood Control Zone District Board of Supervisors authorize the County Executive to sign this agreement.

### **Background and Purpose**

In 2025, the Department of Ecology began a water rights adjudication process in Water Resource Inventory Area (WRIA) 1, commonly known as the Nooksack Basin covering the majority of both incorporated and unincorporated Whatcom County. Landowners who use surface water or groundwater will need to file a court claim form within one year of receiving their summons and self-report details about their historical and current water use. Over time, the court will conduct a legal review of all claimed water rights to determine their validity and priority. It is critically important for all water users in WRIA 1 to complete claim forms to ensure their water rights and to provide the most comprehensive understanding of water use in the WRIA 1 region.

The Department of Ecology is administering funds designated by the Washington State Legislature to Whatcom County for water rights adjudication assistance through a grant agreement. The funding and scope of work for this grant agreement will build and improve upon outreach and assistance efforts to water users participating in the WRIA 1 water rights adjudication that were started in 2023 through a previous grant. New funding will increase public awareness and equip water users with the resources, guidance, and support they need to navigate the legal process to file timely and accurate court claim forms. Assistance will focus particularly on permit-exempt well users, Group B well users, farms, and small water districts in the WRIA 1 region.

## **Funding Amount and Source**

This one time grant from the Department of Ecology's Water Resources Program (OTGP-2026-WhCoPW-00098) will provide \$200,000 to support WRIA 1 Water Rights Adjudication Filing Assistance.

#### Project Short Description:

The RECIPIENT will use this funding to develop and implement outreach efforts related to the Water Resource Inventory Area (WRIA) 1 water rights adjudication with the goal of increasing court claim form submissions by raising public awareness and providing filing assistance to affected water users.

### Project Long Description:

ECOLOGY has begun a water rights adjudication in Water Resource Inventory Area (WRIA) 1, commonly known as the Nooksack Basin. This area includes Bellingham Bay, Birch Bay, Chuckanut, Drayton Harbor, Lake Whatcom, Lummi Bay, Nooksack River, Point Roberts, and Sumas River watersheds, covering the majority of both incorporated and unincorporated Whatcom County.

In March 2024, ECOLOGY mailed adjudication summonses to more than 30,000 identified landowners who use

surface or groundwater within WRIA 1. These water users include holders of approximately 5,000 water right documents as well as about 20,000 permit-exempt wells.

Landowners who use surface water or groundwater will need to file a court claim form within one year of receiving their summons and self-report details about their historical and current water use. Over time, the court will conduct a legal review of all claimed water rights to determine their validity and priority. Municipal utility customers and group systems with a designated representative filing on their behalf are not required to participate.

Whatcom County Council secured funding from the Washington State Legislature to provide filing and legal assistance for the water users participating in the WRIA 1 water rights adjudication. This agreement fulfills that request.

The RECIPIENT will use this funding to develop and implement outreach to maximize participation in the WRIA 1 adjudication process. The outreach will prioritize increasing public awareness and equipping water users with the resources, guidance, and support they need to navigate the legal process to file timely and accurate court claim forms. Assistance will focus particularly on permit-exempt well users, Group B well users, farms, and small water districts.

Due to the nature of the funding source, the total funding must not exceed \$200,000 for the 2025-2026 fiscal year.

#### Overall Goal:

The RECIPIENT'S overall goal is to ensure water users have access to accurate information and receive the support needed to successfully file their court claim forms for the WRIA 1 adjudication.

- b) RECIPIENT shall complete all activities funded by this Agreement and be fully responsible for the proper management of all funds and resources made available under this Agreement.
- c) RECIPIENT agrees to take complete responsibility for all actions taken under this Agreement, including ensuring all subgrantees and contractors comply with the terms and conditions of this Agreement. ECOLOGY reserves the right to request proof of compliance by subgrantees and contractors.
- d) RECIPIENT's activities under this Agreement shall be subject to the review and approval by ECOLOGY for the extent and character of all work and services.

#### 2. AMENDMENTS AND MODIFICATIONS

- b) Publications. When the RECIPIENT or persons employed by the RECIPIENT use or publish ECOLOGY information; present papers, lectures, or seminars involving information supplied by ECOLOGY; or use logos, reports, maps, or other data in printed reports, signs, brochures, pamphlets, etc., appropriate credit shall be given to ECOLOGY.

#### 22. RECORDS, AUDITS, AND INSPECTIONS

RECIPIENT shall maintain complete program and financial records relating to this Agreement, including any engineering documentation and field inspection reports of all construction work accomplished.

All records shall:

- a) Be kept in a manner which provides an audit trail for all expenditures.
- b) Be kept in a common file to facilitate audits and inspections.
- c) Clearly indicate total receipts and expenditures related to this Agreement.
- d) Be open for audit or inspection by ECOLOGY, or by any duly authorized audit representative of the State of Washington, for a period of at least three (3) years after the final grant payment or loan repayment, or any dispute resolution hereunder. RECIPIENT shall provide clarification and make necessary adjustments if any audits or inspections identify discrepancies in the records.

ECOLOGY reserves the right to audit, or have a designated third party audit, applicable records to ensure that the state has been properly invoiced. - b) Purchasing may include such items as: sustainably produced products and services, EPEAT registered computers and imaging equipment, independently certified green cleaning products, remanufactured toner cartridges, products with reduced packaging, office products that are refillable, rechargeable, and recyclable, 100% post-consumer recycled paper, and toxic free products.

#### 28. TERMINATION

#### a) For Cause

ECOLOGY may terminate for cause this Agreement with a seven (7) calendar days prior written notification to the RECIPIENT, at the sole discretion of ECOLOGY, for failing to perform an Agreement requirement or for a material breach of any term or condition. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Failure to Commence Work. ECOLOGY reserves the right to terminate this Agreement if RECIPIENT fails to commence work on the project funded within four (4) months after the effective date of this Agreement, or by any date mutually agreed upon in writing for commencement of work, or the time period defined within the Scope of Work.

Non-Performance. The obligation of ECOLOGY to the RECIPIENT is contingent upon satisfactory performance by the RECIPIENT of all of its obligations under this Agreement. In the event the RECIPIENT unjustifiably fails, in the opinion of ECOLOGY, to perform any obligation required of it by this Agreement, ECOLOGY may refuse to pay any further funds, terminate in whole or in part this Agreement, and exercise any other rights under this Agreement.

Despite the above, the RECIPIENT shall not be relieved of any liability to ECOLOGY for damages sustained by ECOLOGY and the State of Washington because of any breach of this Agreement by the RECIPIENT. ECOLOGY may withhold payments for the purpose of setoff until such time as the exact amount of damages due ECOLOGY from the RECIPIENT is determined.

#### b) For Convenience

ECOLOGY may terminate for convenience this Agreement, in whole or in part, for any reason when it is the best interest of ECOLOGY, with a thirty (30) calendar days prior written notification to the RECIPIENT, except as noted below. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Non-Allocation of Funds. ECOLOGY's ability to make payments is contingent on availability of funding. In the event funding from state, federal or other sources is withdrawn, reduced, or limited in any way after the effective date and prior to the completion or expiration date of this Agreement, ECOLOGY, at its sole discretion, may elect to terminate the Agreement, in whole or part, or renegotiate the Agreement, subject to new funding limitations or conditions. ECOLOGY may also elect to suspend performance of the Agreement until ECOLOGY determines the funding insufficiency is resolved. ECOLOGY may exercise any of these options with no notification or restrictions, although ECOLOGY will make a reasonable attempt to provide notice.

In the event of termination or suspension, ECOLOGY will reimburse eligible costs incurred by the RECIPIENT through the effective date of termination or suspension. Reimbursed costs must be agreed to by ECOLOGY and the RECIPIENT. In no

event shall ECOLOGY's reimbursement exceed ECOLOGY's total responsibility under the Agreement and any amendments. If payments have been discontinued by ECOLOGY due to unavailable funds, the RECIPIENT shall not be obligated to repay monies which had been paid to the RECIPIENT prior to such termination.

RECIPIENT's obligation to continue or complete the work described in this Agreement shall be contingent upon availability of funds by the RECIPIENT's governing body.

# c) By Mutual Agreement

ECOLOGY and the RECIPIENT may terminate this Agreement, in whole or in part, at any time, by mutual written agreement.

#### d) In Event of Termination

All finished or unfinished documents, data studies, surveys, drawings, maps, models, photographs, reports or other materials prepared by the RECIPIENT under this Agreement, at the option of ECOLOGY, will become property of ECOLOGY and the RECIPIENT shall be entitled to receive just and equitable compensation for any satisfactory work completed on such documents and other materials.

Nothing contained herein shall preclude ECOLOGY from demanding repayment of all funds paid to the RECIPIENT in accordance with Recovery of Funds, identified herein.

#### 29. THIRD PARTY BENEFICIARY

RECIPIENT shall ensure that in all subcontracts entered into by the RECIPIENT pursuant to this Agreement, the state of Washington is named as an express third party beneficiary of such subcontracts with full rights as such.

#### 30. WAIVER

Waiver of a default or breach of any provision of this Agreement is not a waiver of any subsequent default or breach, and will not be construed as a modification of the terms of this Agreement unless stated as such in writing by the authorized representative of ECOLOGY.
