WHATCOM COUNTY FIRE PROTECTION DISTRICT 8

A RESOLUTION ADOPTING THE TAX REVENUES AND BUDGET FOR THE YEAR 2024

Whereas, The County Assessor for Whatcom County has advised the Board of Commissioners of Whatcom County Fire Protection District 8 that the assessed value of real properties lying within the boundaries of said District have been estimated; and,

Whereas, Title 84.52.020 of the Revised Code of Washington requires that the District must certify to the county legislative authority for the purpose of levying District taxes, budgets or the estimates of the amount to be raised by taxation; and,

Whereas, the assessed valuation of real properties lying within the boundaries of said District to be used for the actual calculation of the levy for 2023 for the calendar year 2024 is estimated to be \$1,735,625,875: and,

Whereas, the voters of said District passed a Maintenance and Operations Levy in 2020: and,

Whereas, the assessed valuation of new construction of properties lying within the boundaries of said District for the calendar year 2024 is estimated to be \$4,002,005; now,

Now, therefore, be it resolved that

1. The attached hereto Exhibit "A" (by this reference made a part of this resolution) be, and hereby is adopted as the budget of Whatcom County Fire Protection District No 8 for the calendar year of 2024,
2. That the Honorable County Council of Whatcom County, Washington, be and are hereby requested to make a levy for 2024 for said Whatcom County Fire Protection District No 8 in the amount of \$1,164,000.00
3. That the Honorable County Council of Whatcom County, Washington, be and are hereby requested to make a Maintenance and Operations levy for 2024 for said Whatcom County Fire Protection District No 8 in the amount of \$825,000.00.
4. That the County Treasurer of Whatcom County, Washington, be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section 2 above in the amounts and funds specified below:
 - A. \$1,989,000.00 into the Expense Fund of said District
 - B. \$ -0- into the Reserve Fund of said District
 - C. \$ -0- into the Registered Warrant Fund


- D. \$ -0- into the General Obligations Fund
- E. \$ -0- into the Capital Improvement Fund of said District
- F. \$ -0- into the other Fund of said District

5. That one copy of this resolution together with Exhibit "A" shall be delivered to each of the following:

- County Council and Auditor of Whatcom County, Washington

Be it further resolved, that should any adjustments in the above identified amounts become necessary due to tax increase limit legislation, tax limits due to prorating, or due to errors in making estimations on assessed values, all necessary adjustments will be made to the Expense Fund of said District.



WHEREAS, the Fire Commissioners of Whatcom County Fire Dist. 8 has met and considered

its budget for the calendar year 2024; and,

WHEREAS, the districts actual levy amount from the previous year was \$ 1,114,225.00; and,

BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy
is hereby authorized for the levy to be collected in the 2024 tax year.

The dollar amount of the increase over the actual levy amount from the previous year shall be \$ 15,119.72
which is a percentage increase of 1.35697 % from the previous year. This increase is exclusive of
(Percentage increase)

additional revenue resulting from new construction, improvements to property, newly constructed wind turbines,
solar, biomass, and geothermal facilities, and any increase in the value of state assessed property, any annexations
that have occurred and refunds made.
