This is my 3rd time moving back to Birch Bay since 1970 when I fell in love with it the Bay for the first time. I now own a cabin here and I do not plan on moving away again. I can't help but notice that our end of the Bay (the south end) has been forgotten and it frustrates me to no end. After Covid a lot of the Canadians ended up selling their cabins and the majority seem to have been sold as Air B&B. Those buying for this reason appear to only be concerned about income, but not about the Bay. They pave their yards for lower maintenance and throw, grass clippings, dog poo, garbage, etc. right into Terrell Creek. Then behind us, we have Wooldridge ave. The only so-called ditch back there is actually Terrell Creek. Stormwater is supposed to be going to a different ditch, which does not exist. The run-off from Sunset is crazy. There are 2 new houses slated to go in back there now also. This water is part of our flooding problem on Morrison and Terrell and yet nothing has been done about any of this since the '70's. So many of us have called and I'm tired of complaining and want to do something more. I was looking for info with Nooksack Salmon to do a project on Terrell Creek between the C Shoip and Jackson Rd. That is when I came across this opening. I love Birch Bay and Terrell Creek and want to do something constructive for us around here and I believe this just might be the answer. I am a firm believer in educating the public on ways they can help preserve all this beauty for years to come through plantings, etc. I am very passionate about this and will continue to try and think outside the box to find solutions for the problems on the south end of Birch Bay...the neglected end that is in desperate need of help!
