The Whatcom County Council will consider adopting and may amend the following at its July 23, 2019, meeting: **ORDINANCE AMENDING THE PROJECT BASED BUDGET FOR THE AGATE HEIGHTS/ESTATE BAY LANE STORM WATER IMPROVEMENTS FUND, REQUEST NO. 3 (AB2019-376):** This ordinance adds \$360,000 of expenditure authority to the project budget of \$1,308,219, for a total amended project budget of \$1,668,219. **ORDINANCE AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 9 (AB2019-378):** This ordinance adds appropriations to District Court Probation - \$120,000; Non-Departmental - \$129,122; Sheriff - \$5,000; Stormwater Fund - \$28,000, for a total supplemental amount of \$282,122. **ORDINANCE AMENDING WHATCOM COUNTY CODE 2.46.020 AND 2.46.030 TO AMEND THE WHATCOM COUNTY INCARCERATION PREVENTION AND REDUCTION TASK FORCE PURPOSE AND FUNCTION (AB2019-389):** This ordinance expands the purpose and function of the Incarceration Prevention and Reduction Task Force (purpose and function) related to prevention, intervention, treatment, and aftercare. **RESOLUTION AMENDING THE WHATCOM COUNTY FLOOD CONTROL DISTRICT SUBZONES BUDGET, REQUEST NO. 4 (COUNCIL ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2019-380):** This ordinance adds appropriations to the Storm Water Fund - \$28,000; Birch Bay Watershed & Aquatic Resources Management District - \$190,000, for a total supplemental amount of \$218,000. Council introduced the above at its July 9, 2019, meeting. 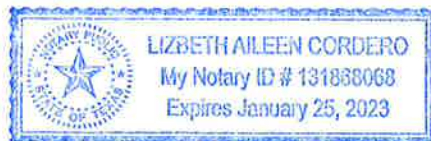
