Council Chair Kaylee Galloway called the meeting to order at 9:17 a.m. in a hybrid meeting.

Galloway stated they would be organizing their standing committees in each of the committee meetings today so they would be skipping that section for now (since the committees are now all seven members and they will only be deciding chairs).

*Clerk's note:* One appointment (Health Board) was held (via a vote below) until the Health Board meeting on February 3rd.

Council Chairperson (Acts as Chair of Council acting in other capacities, Law Library Board, SWISS Exec. Committee, County Finance Committee)

***Buchanan moved*** and Rienstra seconded to appoint Galloway as chair of the Council for 2026.
