3. This implementation plan shall, to the maximum extent possible, be developed in collaboration with the Child and Family Well-being Taskforce, an existing community board established by the Whatcom County Council, and shall be APPROVED BY THE COUNTY COUNCIL AND transmitted to the County Executive by March 31, 2023, and every 2 years thereafter to be included as part of the budget submitted to the Council.

• Calling on Congress to define an expansive national right to abortion in statute

• Calling on both political parties to appoint pro-choice justices to the US Supreme Court, courts of appeals, and federal district courts
