**CERTIFYING PROPERTY TAX LEVIES FOR COLLECTION IN 2022 TO THE  
COUNTY ASSESSOR**

**WHEREAS**, pursuant to the provisions of RCW 84.52.070, it is the duty of the Whatcom County Council to certify to the County Assessor the amount of taxes levied upon the property in the County for County purposes and the respective amounts of taxes levied by the board for each taxing district within or coextensive with Whatcom County in 2021, for district purposes.

**NOW, THEREFORE, BE IT RESOLVED**, the Whatcom County Council hereby certifies to the Whatcom County Assessor the respective amounts of taxes levied by the board for each taxing district as outlined in Exhibit A to this resolution.

**BE IT FURTHER RESOLVED**, in making such certification the Council is relying on information provided by the taxing districts.

**BE IT FINALLY RESOLVED**, should the valuation of one or more districts change, the County Assessor, with permission of the taxing district, is hereby authorized to adjust the amount of taxes levied, upon written notification to the Whatcom County Council.
