The Recipient will develop and implement a collaborative process to identify local solutions for water availability issues in the Nooksack [Water Resources Inventory Area (WRIA) 1]. The process for addressing water availability issues will run parallel to, and complement water rights adjudication.

Project Long Description:

The Recipient will develop and facilitate a collaborative process, and conduct supporting technical studies as necessary, to develop solutions to meet instream flows and out-of-stream water supply needs throughout the Nooksack watershed WRIA (Water Resources Inventory Area) 1. Water users in WRIA 1 have long standing conflicts concerning water supply and low stream flows in the dry summer months. It is likely the problems will worsen with the continuing impacts of climate change. For the past 20 years, local parties have worked hard to address water supply issues. They have adopted a Watershed Management Plan, conducted many technical studies, and attempted to resolve water rights

issues. A pending adjudication of water rights will elevate the region's challenges.

In 2021, the Washington State Legislature provided funding for the Recipient to develop and implement a collaborative process to identify local solutions for water availability issues in WRIA 1.

As specified in the legislative budget proviso, these funds are provided solely for the Recipient to facilitate and mediate process development and implementation among parties, develop planning and technical information, and assess local solutions. At a minimum, the collaborative process ("Solutions Table") must seek to provide opportunities for discussion of increasing salmon populations and preserving farmland. The process will include local water users and water right holders, and will complement water rights adjudication in the watershed.

The Recipient will design the process to bring together key stakeholders to determine each party's needs, and find ways to meet those needs. The primary focus of this process development is to resolve water quantity and instream flow issues; however, because water supply issues are inextricably linked to water quality, salmon habitat, land use, and other issues, the process may also address these issues.

Although much technical work has been done, additional technical studies may be needed to fully develop solutions. Implementation of the process will include identifying projects to increase minimum instream flows for the benefit of ESA-listed salmonids and other wildlife, and to provide more secure and reliable out-of-stream water supplies.

This funding must be spent in the respective fiscal year it is provided (\$125,000 in fiscal year 2022; \$125,000 in fiscal year 2023), and cannot be rolled over from one fiscal year to the next due to the nature of the funding source.

Overall Goal:

Task Title:

Task Description:

This task relates to the quantification of timing and magnitude of groundwater pumping on streamflow depletion. A key piece of information needed to manage water use in WRIA 1 is an understanding of the timing and magnitude of groundwater pumping on stream flows, particularly in areas with high agricultural water use. To fill this information gap, a field study will be conducted to quantify these effects in a range of hydrologic and hydrogeologic conditions within WRIA 1. This work will be conducted within the framework of the WRIA 1 Watershed Management Board structure. Specific tasks include:

A. The RECIPIENT will prepare and submit to ECOLOGY for approval a Quality Assurance Project Plan (QAPP). The QAPP must follow ECOLOGY's Guidelines and Specifications for Preparing Quality Assurance Project Plans for Environmental Studies, A QAPP template is available at http://www.ecy.wa.gov/programs/eap/qa/docs/QAPPtool/index.html. The RECIPIENT must have an approved QAPP signed by both the RECIPIENT and ECOLOGY before any monitoring activity. Any monitoring/data collection conducted before the QAPP receives final approval is not eligible for reimbursement.

- B. The RECIPIENT will, in accordance with the approved QAPP, and in consultation with the WRIA 1 Watershed Staff Team and the Whatcom Groundwater Model Technical Work Group:
- a. Conduct a study to quantify the timing and magnitude of groundwater pumping on stream flows in areas that will facilitate updating and/or refining the Whatcom Groundwater Model. Groundwater and surface water data will be collected in at least three different watersheds that represent a range of hydrologic and hydrogeologic conditions throughout WRIA 1. The watersheds will be selected using the Whatcom Groundwater Model, existing hydrogeologic information, and land and water use information. Ambient groundwater level data will be collected from networks of wells or piezometers, and stream flows will be measured using streamflow monitoring devises located in nearby surface water bodies for a period of one year. (It is anticipated that the length of the monitoring period will extend beyond one year, but any subsequent work will be conducted utilizing other funding sources.) Data will be collected during times of groundwater pumping and when wells are not pumping.
- b. The Recipient will prepare a report that evaluates the data collected and any future study recommendations.
- c. Update and/or refine the Whatcom Groundwater Model.
- C. The RECIPIENT will coordinate with ECOLOGY'S Environmental Information Management (EIM) system coordinator to submit all data collected to ECOLOGY's EIM database.
- *As described in Project Long Description, total funding must be spent in the respective fiscal year it is provided (\$125,000 in fiscal year 2022; \$125,000 in fiscal year 2023), and cannot be rolled over from one fiscal year to the next due to the nature of the funding source. Task 1-3 total costs will not exceed \$125,000, per respective fiscal year.

22. RECORDS, AUDITS, AND INSPECTIONS

RECIPIENT shall maintain complete program and financial records relating to this Agreement, including any engineering documentation and field inspection reports of all construction work accomplished.

All records shall:

- b) Be kept in a common file to facilitate audits and inspections.

When in the best interest of ECOLOGY, ECOLOGY may at any time, and without cause, suspend this Agreement or any portion thereof for a temporary period by written notice from ECOLOGY to the RECIPIENT. RECIPIENT shall resume performance on the next business day following the suspension period unless another day is specified by ECOLOGY.

27. SUSTAINABLE PRACTICES

In order to sustain Washington's natural resources and ecosystems, the RECIPIENT is fully encouraged to implement sustainable practices and to purchase environmentally preferable products under this Agreement.

28. TERMINATION

a) For Cause

ECOLOGY may terminate for cause this Agreement with a seven (7) calendar days prior written notification to the RECIPIENT, at the sole discretion of ECOLOGY, for failing to perform an Agreement requirement or for a material breach of any term or condition. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Failure to Commence Work. ECOLOGY reserves the right to terminate this Agreement if RECIPIENT fails to commence work on the project funded within four (4) months after the effective date of this Agreement, or by any date mutually agreed upon in writing for commencement of work, or the time period defined within the Scope of Work.

Non-Performance. The obligation of ECOLOGY to the RECIPIENT is contingent upon satisfactory performance by the RECIPIENT of all of its obligations under this Agreement. In the event the RECIPIENT unjustifiably fails, in the opinion of ECOLOGY, to perform any obligation required of it by this Agreement, ECOLOGY may refuse to pay any further funds, terminate in whole or in part this Agreement, and exercise any other rights under this Agreement.

Despite the above, the RECIPIENT shall not be relieved of any liability to ECOLOGY for damages sustained by ECOLOGY and the State of Washington because of any breach of this Agreement by the RECIPIENT. ECOLOGY may withhold payments for the purpose of setoff until such time as the exact amount of damages due ECOLOGY from the RECIPIENT is determined.

b) For Convenience

ECOLOGY may terminate for convenience this Agreement, in whole or in part, for any reason when it is the best interest of ECOLOGY, with a thirty (30) calendar days prior written notification to the RECIPIENT, except as noted below. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Non-Allocation of Funds. ECOLOGY's ability to make payments is contingent on availability of funding. In the event funding from state, federal or other sources is withdrawn, reduced, or limited in any way after the effective date and prior to the completion or expiration date of this Agreement, ECOLOGY, at its sole discretion, may elect to terminate the Agreement, in whole or part, or renegotiate the Agreement, subject to new funding limitations or conditions. ECOLOGY may also elect to suspend performance of the Agreement until ECOLOGY determines the funding insufficiency is resolved. ECOLOGY may exercise any of these options with no notification or restrictions, although ECOLOGY will make a reasonable attempt to provide notice.

In the event of termination or suspension, ECOLOGY will reimburse eligible costs incurred by the RECIPIENT through the effective date of termination or suspension. Reimbursed costs must be agreed to by ECOLOGY and the RECIPIENT. In no Template Version 12/10/2020

event shall ECOLOGY's reimbursement exceed ECOLOGY's total responsibility under the Agreement and any amendments. If payments have been discontinued by ECOLOGY due to unavailable funds, the RECIPIENT shall not be obligated to repay monies which had been paid to the RECIPIENT prior to such termination.

RECIPIENT's obligation to continue or complete the work described in this Agreement shall be contingent upon availability of funds by the RECIPIENT's governing body.

c) By Mutual Agreement

ECOLOGY and the RECIPIENT may terminate this Agreement, in whole or in part, at any time, by mutual written agreement.

d) In Event of Termination

All finished or unfinished documents, data studies, surveys, drawings, maps, models, photographs, reports or other materials prepared by the RECIPIENT under this Agreement, at the option of ECOLOGY, will become property of ECOLOGY and the RECIPIENT shall be entitled to receive just and equitable compensation for any satisfactory work completed on such documents and other materials.

Nothing contained herein shall preclude ECOLOGY from demanding repayment of all funds paid to the RECIPIENT in accordance with Recovery of Funds, identified herein.

29. THIRD PARTY BENEFICIARY

RECIPIENT shall ensure that in all subcontracts entered into by the RECIPIENT pursuant to this Agreement, the state of Washington is named as an express third party beneficiary of such subcontracts with full rights as such.

30. WAIVER

Waiver of a default or breach of any provision of this Agreement is not a waiver of any subsequent default or breach, and will not be construed as a modification of the terms of this Agreement unless stated as such in writing by the authorized representative of ECOLOGY.
