Ordinance introduced June 7, 2022. ORDINANCE (2022-049) CLOSING THE AGATE HEIGHTS/ESTATE BAY LANE STORMWATER IMPROVEMENTS FUND 365 (AB2022-320) This ordinance closes the Agate Heights/Estate Bay Lane Stormwater Improvements Fund 365 and returns remaining funds to Real Estate Excise Tax II Fund. Ordinance introduced June 7, 2022. INTERLOCAL AGREEMENTS WITH BELLINGHAM, EVERSON, LYNDEN, NOOKSACK, AND SUMAS RELATED TO URBAN GROWTH AREAS (AB2022-346) The Council authorized the County Executive to enter into interlocal agreements with the cities of Bellingham, Everson, Lynden, Nooksack, and Sumas concerning planning, annexation and development within urban growth areas. The new interlocal agreements replaces existing agreements that expire on June 30, 2022. ORDINANCE (2022-050) CLOSING THE NORTHSHORE DRIVE/EDGEWATER LANE STORMWATER IMPROVEMENTS FUND 381 (AB2022-321) This ordinance closes the Northshore Drive/Edgewater Lane Stormwater Improvements Fund 381 and returns remaining funds to Real Estate Excise Tax II Fund. Ordinance introduced June 7, 2022, RESOLUTION (2022-031) AMENDING THE FLOOD CONTROL ZONE DISTRICT & SUBZONES 2022 BUDGET, REQUEST NO. 3, IN THE AMOUNT OF \$5,250,617 (COUNCIL ACTING AS THE FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2022-322) This resolution amends the Flood Control Zone District and Subzones 2022 budget as follows: From the Flood Control Zone District Fund: appropriate \$187,075 in River & Flood to fund additional capacity as follows. ORDINANCE (2022-053) AMENDING THE 2022 WHATCOM COUNTY BUDGET, REQUEST NO. 9, IN THE AMOUNT OF \$15,838,261 (AB2022-329) This ordinance amends the 2022 Whatcom County Budget as follows: From the General Fund: appropriate \$59,637 in Assessor to fund a new Chief Appraiser position; appropriate \$41,000 in Health to fund moving expenses; appropriate \$17,000 in Non Departmental to partially fund a Natural Resources Environmental Manager position; appropriate \$43,706 in Prosecuting Attorney to fund a new Records Assistant position; appropriate \$67,296 in Prosecuting Attorney to fund a new Investigator Supervisor position; appropriate \$2,500 in Sheriff to fund Organized Crime Drug Enforcement Task Force investigations from grant proceeds; appropriate \$10,236 in Sheriff to fund FN303 less-lethal projectiles. From the Road Fund: appropriate \$827,690 to fund a transfer in support of the North Lake Samish Road Bridge Replacement project budget amendment #1.; appropriate \$68,946 to fund a new accounting supervisor position and reclassification of an existing clerk position. From the Swift Creek Sediment Management Fund, appropriate \$440,000 to fund 2022 and 2023 Swift Creek maintenance. From the American Rescue Plan Act Fund, appropriate \$2,200,000 to fund acquisition of affordable housing properties. From the Conservation Futures Fund, appropriate \$1,090,250 to fund two agricultural conservation easements and one forestry conservation easement partially funded by grants and ag mitigation fee proceeds. From the Real Estate Excise Tax II Fund, appropriate \$295,000 to fund a transfer in support of the Shallow Shore Culvert Relocation project. From the Public Utilities Improvement Fund, appropriate \$10,675,000 to fund Economic Development Initiative infrastructure allocations. Ordinance introduced June 7, 2022.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on July 12, 2022, or at a later date: ORDINANCE PROVIDING FOR SUBMISSION TO THE QUALIFIED VOTERS OF WHATCOM COUNTY A PROPOSITION RENEWING THE LEVY OF A REGULAR PROPERTY TAX AT A RATE OF \$.199
OR LESS PER \$1000 ASSESSED VALUATION TO CONTINUE TO PROVIDE EMERGENCY MEDICAL SER-VICES (AB2022-365) This ordinance submits to the Whatcom County Auditor, for inclusion on the November 8, 2022 general election, a proposition renewing the levy of a regular property tax of \$0.199 or less per thousand dollars of assessed valuation for each of the six consecutive years, with collection beginning in 2023, for the continued provision of emergency medical services. Ordinance introduced June 21, 2022.


