Strong answered what the difference is between permitted use and accessory use as far as the Code goes and how that would be interpreted by Planning.

Kershner spoke about the following concerns:

- Whether nuisance laws are already included in State regulation
- Not having the data on how many complaints they have received about short term rentals and whether they would be putting regulations in place when they do not know what the extent of the problem (if there is one) is
- The Planning Department having to manage the program
- Having to register and pay a fee if you are just renting out your home for two weeks a year
- Whether this would be duplicating State regulations
- What the safety requirements would be and what the safety checklist that is required by the Building Official and Fire Marshall might be
- The condition for Lake Whatcom Properties regarding onsite septic system inspections which is already required by the Code and possible duplicated efforts between the Health Department and the Planning Department in monitoring that

Elenbaas stated the Planning Commission heard many public comments against the regulations several years ago and did not move forward with it at that time, even before the addition of State regulations. He does not want to see County Planning staff spending time on regulating and answering phone calls about vacation rentals but would rather see them work on issues that are more important to our community.
