Attached is a contract between Whatcom County and the State Department of Commerce for your review and signature:

• Background and Purpose:

District Court Prosecutor's handle a large share of serious domestic violence cases, and it is the only court at the county that facilitates supervision of domestic violence offenders on probation. The legislature requires prosecutors to keep victims informed and to provide emotional support for victims of violence and sex crimes, including having the advocate present at defense interviews and judicial proceedings (R.C.W. 7.69.030). Effective prosecution depends on cooperation from victims of crime. Staffing the position is absolutely necessary to ensure the health and well-being of the community and victims of domestic violence.

• Funding Amount and Source:

Funding for this grant award amount will not exceed \$60, 461 and is provided by the Washington State Department of Commerce. These funds will be included in the 2023 Budget and the County agrees to pay for the remaining \$11,559.00 to cover a portion of the position's salary and benefits expenses. Council approval is required as funding exceeds \$40,000.

• Differences Between Previous Contract:

The Prosecutor's office has received this same grant in previous years with only a few changes to the SFY2023.
