This ordinance was introduced January 24, 2023. ORDINANCE AMENDING THE WHATCOM COUNTY BUDGET, REQUEST NO. 2, in Y THE AMOUNT OF SC,395,173 (AB2023-077). This ordinance amends the 2023 Whatcom County Budget by adding the following additional amounts: General Fund - \$546,087 (Health Department); Veterans Relief Fund - \$102,467: Behavioral Health Program Fund - \$1,936,000; Countywide Emergency Medical Fund - \$138,360; Solid Waste Fund - \$72,259; Auditor's C&M Fund - \$100,000; Emergency Management Fund - \$2,866,000; Administrative Services - \$41,500.
