### **Ordinance 2022-045:**

Established a dedicated fund to support young children and their families



- Annual for ten years, starting in 2023
- \$9.976 million expected in 2023 (may vary year-to-year)
- Implementation Plan must be approved by County Council and submitted to County Executive by March 31, 2023

The Healthy Children's Fund is an effort to transform our community by providing critical, new resources for children and families.



### Vision

#### **Early Learning & Care**

- •Reduce or eliminate waiting lists for early learning & care and support services.
- •Early learning & care is affordable and families have high-quality options.
- •An easy-to-use, comprehensive early learning & care network with regional hubs known for excellence and a thriving, professionalized workforce.

## Support for Vulnerable Children

- Families can access services and care at the time it is needed.
- Resources are available to support parents in pregnancy, newborns, and new parents/caregivers.
- Support for children and families at risk of or experiencing homelessness and more safe housing options.

## **Early Learning & Care Strategies**

- Provide funds for small capital projects to expand, renovate, or repurpose buildings to increase early learning & care slots in a mixed-delivery system.
- Coordinate current and develop additional pathways to ensure a stable early learning & care workforce to deliver high-quality programs for children.
- Improve access to early learning & care through subsidies that reduce the cost of programs for children from families which are cost-burdened.
- Ensure access to early learning and care by promoting the expansion and retention of the early learning & care workforce.
- Create regional early learning & care hubs that include shared administrative services, colocated early learning and other services for children and families, and support for smaller providers in the County (i.e. the "hub and spoke model").
- Support innovative approaches to meet various Healthy Children's Fund goals related to Early Learning & Care.

### Supporting Vulnerable Children

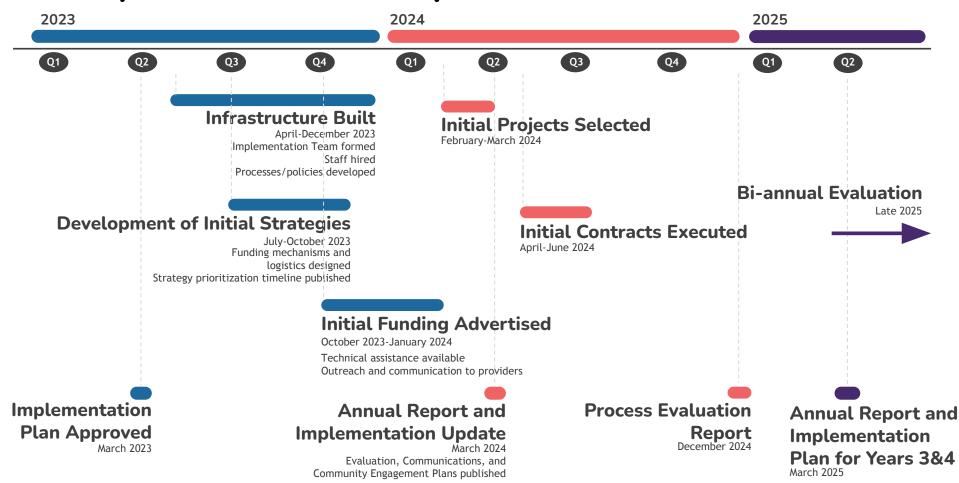
- Recruit Mental & Behavioral Health Workforce to Whatcom County.
- Develop and/or expand resources and programs for families who disproportionately experience housing instability.
- Expand and enhance early parenting supports.
- Integrate and co-locate services via coordinated access to resource navigation using the Help Me Grow model.

### Administration



- 9% of the fund over the life of the levy
- High upfront and frontloading costs for evaluation, audits, other professional contracts
- Low initial cost for staff due to current ARPA-funded positions
- Adds Evaluation/Assessment Specialist and Associate Contract Coordinator

### **Key Considerations**

 Start-up and launch will require time, which will impact Implementation and Evaluation timing

 Outstanding questions, particularly regarding contracts and funding mechanisms, are still in process

### Package for Council consideration:

- Resolution accepting the implementation plan (with plan following as Exhibit A)
- Three supplemental budget requests:
  - admin budget
  - vulnerable children
  - early learning and care



#### **Council Process:**

- 2/21: Briefing on implementation plan/program components in COW, resolution/plan introduction
- 3/7: Briefing on supplemental budget requests and discussion of questions on program/implementation plan in COW, public hearing, supplemental budget request introduction
- 3/21: Discussion and decisions on amendment matrix in COW, passage of amended resolution and supplemental budget requests
- 3/31: Transmittal to County Executive
