ACTION TAKEN

The Whatcom County Council adopted the following at its February 21, 2023, meeting: ORDINANCE (2023-006) AMENDING THE PROJECT BUDGET FOR THE SHALLOW SHORE PROJECT BASED BUDGET FUND, REQUEST NO. 2 (AB2023-098): This ordinance amends the project-based budget for the Shallow Shores Culvert Relocation Project in the amount of \$135,000, to be funded by a transfer from the REET II fund. This ordinance was introduced on February 7, 2023. ORDINANCE (2023-007) AMENDING THE WHATCOM COUNTY BUDGET, REQUEST NO. 3, IN THE AMOUNT OF \$4,704,200 (AB2023-202). This wife is the state of the state AMENDING THE WHATCOM COUNTY BUDGET, REQUEST NO. 3, IN THE AMOUNT OF \$4,791,300 (AB2023-108): This ordinance amends the 2023 Whatcom County Budget by adding the following additional amounts: General Fund-\$324,784 (Non-Departmental), \$304,495 (Sheriff); Road Fund - \$222,300; Low Income Housing Fund - \$120,000; American Rescue Plan Act Fund - \$2,190,931; Solid Waste Fund - \$180,000; Emergency Management Fund - \$28,430; Conservation Futures Fund - \$608,000; Real Estate Excise Tax II Fund - \$135,000; Public I Itilities Improvement Fund - \$130,000; Ferry Sys-Fund - \$28,430; Conservation Futures Fund - \$000,000; Field Estate Excise Ida.

If Fund - \$135,000; Public Utilities Improvement Fund - \$130,000; Ferry System Fund - \$494,000; Equipment Rental and Revolving Fund - \$53,360. This ordinance was introduced on February 7, 2023. ORDINANCE (2023-004) REGARDING INSTALLATION OF STOP SIGNS ON CERTAIN COUNTY ROADS (AB2023-095): This ordinance authorizes the installation of stop signs at the intersection of Birch Point Road and Birch Bay Drive for southbound traffic on Birch Point Road and westbound traffic on Birch Bay Drive. This ordinance was introduced February 7, 2023, ORDINANCE (2023-005) ESTAB-LISHING A SPEED LIMIT FOR THE PLAT OF HARBOR VIEW HEIGHTS A \$2023 - 097 (AB2023-097): This ordinance establishes a speed limit of 25 MPH for all roads within the Plat of Harbor View Heights, this includes the following roads Crest Dr, Harborview Dr, Harbor Ct and Terrace Ave. This ordinance was introduced on February 7, 2023. A

The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on March 7, 2023, or at a later date: ORDINANCE UPDATING WHATCOM COUNTY CODE (WCC)

12.36, LOAD LIMITS, AND REPEALING WCC 10.30, PERMANENT WEIGHT LIMITATIONS (AB2023-122): This ordinance amends Whatcom County Codes 10.36 and repeals Whatcom County Codes 10.36 related to load. WEIGHT LIMITATIONS (AB2U23-122): This ordinance amends whatcom County Code 12.36 and repeals Whatcom County Code 10.30 related to load limits on county roads and bridges to clarify administrative functions. This ordinance was introduced February 21, 2023. RESOLUTION ADOPTING THE HEALTHY CHILDREN'S FUND IMPLEMENTATION PLAN (AB2023-124). 127): This resolution approves the implementation plan for the Healthy Children's Fund (public hearing scheduled for March 7, Council action anticipated March 21). This resolution was introduced February 21, 2023.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on March 7, 2023, or at a later date: ORDINANCE SUSPENDING WHATCOM COUNTY CODE 1.28 TO UPDATE THE CORRECTIONAL FACILITIES OPERATIONAL STANDARDS (AB2023-156): This ordinance suspends Whatcom County Code 1.28 for up to eleven (11) months to provide adequate time for the Law and Justice Committee and the County Council to review the correctional facilities operational standards. This ordinance was introduced on February 21, 2023.
