The Whatcom County Council will hold a public hearing, consider adopting, and may amend the following at its 6 p.m. meeting on March 21, 2023, or at a later date: ORDINANCE DECLARING PUBLIC NECCESSITY FOR AND THE AUTHORIZATION TO ACQUIRE CERTAIN PROPERTY RIGHTS BY EMINENT DOMAIN FOR THE E. SMITH ROAD AND HANNEGAN ROAD INTERSECTION IMPROVEMENTS PROJECT (AB2023-158). This ordinance authorizes legal proceedings if necessary to acquire by condemnation certain real property interests in the following subject property for a roadway project. The subject property is identified as a portion of the parcel located at the intersection of Hannegan Road and East Smith Road designated as Whatcom County Tax Parcel No. 3903330364870000.
