Attached is a contract amendment between Whatcom County and Kulshan Supported Employment for your review and signature.

Background and Purpose

This contract provides "Pathways to Employment" and "Community Inclusion" services to eligible individuals with developmental disabilities. Pathways to Employment services are designed to assist individuals to pursue and maintain paid employment in integrated community settings. Community inclusion services are designed to increase participation in the community. In January 2023, 350 adults in Whatcom County received employment services and 36 received community inclusion services. Kulshan Supported Employment is one of four community providers offering these services. This amendment extends the contract for an additional year (07/01/2023 – 06/30/2024) and increases the annual allocation by \$384,370 compared to the 2022 – 2023 contract period. This contract supports the Department of Social and Health Services' (DSHS) data projections for Whatcom County and an increase in the DSHS established rate lids, as follows:

Individual Employment	\$84/hour	\$105.60/hour
Group Supported Employment	\$72/hour	\$91.04/hour
Community Inclusion	\$39/hour	\$61.36/hour

Funding Amount and Source

Funding for this contract is provided by the Washington State DSHS, Developmental Disabilities Administration and local DD Millage. Total compensation under this contract depends on the number of clients and the types of services authorized, however, the estimated authorized service level for this contract period (07/01/2023 – 06/30/2024) is \$1,547,837. Council authorization is required as this amendment increases funding by more than 10% of the amount authorized by Council on 06/29/2021.
