Whatcom County Council will have a public hearing, will consider adoptguoid: hearing, will consider adopting, and may amend the following at its July 23, 2019 meeting, or at a later date: ORDINANCE GRANTING NORTHWEST WATER ASSOCIATION A FRANCHISE AND THE RIGHT, PRIVILEGE, AND AUTHORITY THEREUNDER TO LOATE SET EPECT LAY CON-CATE, SET, ERECT, LAY, CON-STRUCT, EXTEND, SUPPORT, AT-TACH, CONNECT, MAINTAIN, RE-PAIR, REPLACE, ENLARGE, OP-ERATE AND USE FACILITIES IN, UPON, ALONG, ACROSS AND THROUGH THE FRANCHISE AREA TO ALLOW FOR THE PROVISION OF WATER SERVICES (2019-347): This ordinance grants a 25 year non-exclusive franchise to construct, erect, alter, lay, support, consect, improve, renew, replace, repair, operate and maintain water fransmission and distribution facilities upon, under, over across and along certain roads and other areas in Whatcom County. The 'Franchise Area" is legally described as folfews: all public county roads, county public ways, and county property now owned or hereafter dedicated to the County with Sections 33, 34, and 35, Township 39 North, Range 2 East of W.M., and Sections 2 and 3, Township 38 North, Range 2 East of W.M. in Whatcom County, Washington as may hereafter the amended and attached hereto. addition, any portion of Smith Road, Northwest Onive, Waschike Road, Alerich Road, Slater Road, and Pacific dight road, state road, and nache the previous described area. "Facilities" means collectively, any and all water transmission and distribution systems, including but not limited to tanks, meters, pixes, mains, services, valves, macholes, pressure reducing valves ("PRVs"), pump stations, meter stations and any and all other equipment, appliances, attachments, ap-curtenances and other items necessary, convenient, or in any way appertaining to any and all of the toregoing, whether the same be located over or under ground.
