GROUP, LLC, A NON-EXCLUSIVE FRANCHISE FOR THE RIGHT OF ENTRY, USE, AND OCCUPATION OF THOSE PUBLIC RIGHTS-OF-WAY WITHIN THE COUNTY FOR TELECOMMUNICATIONS SER-VICES. (AB2021-715): This ordinance grants a non-exclusive ten (10) year franchise to install, construct, erect, operate, maintain, repair, relocate and remove Grantee Facilities in. on, upon, along and/or across those Rights-of-Way for the purposes of offering and providing Telecommunications Services. 
