The Whatcom County Council adopted the following at its January 15, 2019, meeting: ORDINANCE (2019-005) ADOPTING AMENDMENTS TO WHATCOM COUNTY CODE TITLE 17 FLOOD DAMAGE PREVENTION This ordinance (AB2019-039): amendments adopts Whatcom County Flood Damage Prevention Code (Title 17) that include the following: Reference to a new flood insurance study (FIS) and flood insurance rate (FIRM) map panets for Whatcom County, amend-ments required to make Title 17 consistent with the code of Federal consistent with use Regulation (CFR's), and revisions recommended by FEMA for clarification purposes. The FIS and FRM will become effective on January 18, 2019. ORDINANCE (2019-006) WHATCOM COUNTY CODE 16.20 WHATCOM COUNTY SHELLFISH PROTECTION DISTRICT (AB2019-042): This ordinance extends the sunset date for the Orayton Harbor, Portage Bay, and Birch Bay Shellfish Protection tricts to December 31, 2022. It also dissolves the Birch Bay Shellfish Protection District Advisory Commit-tee and adds the shellfish protection advisory duties to the Birch Bay Wa-ter and Aquatic Resources Management (BEWARM) District Advisory Committee.
