COUNCIL ACTION PROPOSED

The Whatcom County Council will consider adopting and may amend the following at its March 26, 2019, meeting:

ORDINANCE INCREASING SHERIFF'S OFFICE PETTY CASH FUND (AB2019-150): *2019-150* This ordinance authorizes the increase in the Sheriff's Office petty cash fund to a total of \$300 for three separate cash drawers in order to provide change when receipting payments from customers.

ORDINANCE REPEALING ORDINANCE 2019-017 WHATCOM COUNTY CODE SECTION 6.05, ANIMAL CONTROL (AB2019-156): *2019-156* This ordinance repeals Ordinance 2019-017 that was adopted due to a clerical error.

ORDINANCE AMENDING THE 2019 BUDGET, REQUEST NO. 4 (AB2019-160): *2019-160* This ordinance adds appropriations to the Health Fund (\$114,985), Sheriff (\$14,740), Road Fund (\$450,000), Behavioral Health Program Fund (\$249,927), Solid Waste Fund (\$560,000), Convention Center (Lodging Tax) Fund (\$35,000), Real Estate Excise Tax 1 Fund (\$836,000), in a total supplemental amount of \$2,260,652. Council introduced the above at its March 12 meeting. Public documents are available for review in the Council Office, 311 Grand Avenue, Bellingham and at www.co.whatcom.wa.us/council. Meetings are in the Council Chambers, same address, at 7:00 p.m., unless otherwise announced. The Council Chambers is handicapped accessible. 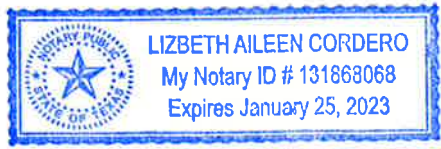
