WHEREAS, Ordinance 2019-017 was introduced with the proper redline changes to Section 6.04 of the Whatcom County Code; and

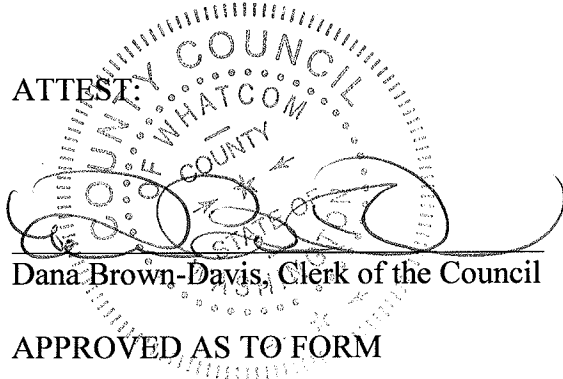
WHEREAS, Due to a clerical error in publishing the proposed ordinance, the wrong ordinance was submitted for council review; and




