(AB2019-249) amends Whatcom County Code Title 24.01.051, Health Department Advisory Board Created, to increase fo-cus on board diversity, reconfigure community segment representation. increase the number of positions on the board, reduce term length and clarify term limits, and update language and structure to reflect curguage and structure to reflect cur-rent practices and language. ORDI-NANCE (2019-041) AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$907,787 (AB2019-263): This ordinance adds appropriations to the following budgets: \$783,500 to Sheriff; Non-Departmental; to \$20,000 to Veteran's Relief Fund; \$41,000 to Behavioral Health Programs Fund; and \$54,356 to Public Utilities Improvement (EDI) Fund, for a total supplemental amount of \$907,787. **ORDINANCE** (2019-042) AMENDING THE PROJECT BUDGET FOR THE PUBLIC SAFE-TY RADIO SYSTEM FUND, RE-QUEST NO. 1 (AB2019-265): AB 2019-265 This ordinance adds \$54,356 of expenditure authority to the project budget of \$96,802 for a total amended preliminary project budget of \$451,158.
