The Whatcom County Council will consider adopting and may amend the following at its Wednesday, September 10, 2019, meeting: **ORDINANCE AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 11, IN THE AMOUNT OF \$986,542 (AB2019-419)**: This ordinance adds funding to the following: \$10,000 to Sheriff; \$23,363 to County Clerk; \$45,018 to non-departmental; \$307,886 to Behavioral Health Program Fund; \$600,275 to Public Utilities Improvement Fund (EDI). Council introduced this ordinance at its August 7, 2019, meeting. 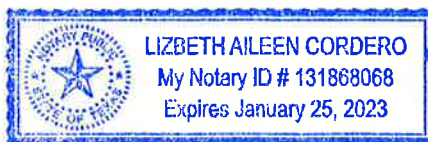
