

The Whatcom County Council will The Whatcom County Council will hold a public hearing, consider approving, and may amend the following at its October 8, 2019, meeting, or at a later date: INTERLOCAL AGREEMENT BETWEEN THE CITY OF BELLINGHAM AND WHATCOM COUNTY FOR 2019 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD (AB2019-452): As required by the U.S. Department of Justice, Office of Justice, partment of Justice, Office of Justice Programs, Bureau of Justice Assistance, the Edward Byrne Memorial Justice Assistance Grant (JAG Program FY2018 Local Solicitation is made available to the citizens for public review and comment. Total Whatcom County Jurisdiction allocation is \$36,076 (with \$22,685 for the City of Bellingham and \$13,391 for Whatcom County.) The City of Bellingham will administer the grant Bellingham will administer the grant and provide \$13,391 to Whatcom County Sheriff's Office to purchase ballistic resistant vests.
