The Whatcom County Council will consider adopting and may amend the following at its October 22, 2019, meeting: ORDINANCE AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 13 (AB2019-508): This ordinance adds appropriations to: \$902,724 out of Non-Departmental wage and benefit reserves and distribute to all General Fund Departments in accordance with 2019 wage settlements and benefit adjustments. Amount of \$375,570: To appropriate \$65,000 in Non-Departmental to fund pass-through census grant to the Opportunity Council. \$77,500 in Planning & Development Services to fund Buildable Lands program from grant funding. From the Election Reserve Fund: To appropriate \$27,378 to fund civic engagement activities and prepaid postage envelopes from state grant proceeds. From the Public Utilities Improvement (EDI) Fund To appropriate \$205,692 to fund Housing Affordable Impact Fee Loan program. Council introduced the above at its October 8, 2019, meeting.
