The Whatcom County Council will have public hearings. consider adopting, and may amend the following at its January 14, 2020, meeting, or at a later date: ORDI-NANCE AMENDING WHATCOM COUNTY CODE CHAPTERS 11.16 AND 11.20 TO PROTECT LAKE SAMISH SHORELINE PROPERTIES AND LAKE SAMISH WATER RECREATION (AB2019-480): This ordinance amends boating and swimming regulations for Lake Samish; specifically speed regulations (11.16.030) and regulations related to activities allowed within specific distances from the shore-line (WCC 11.20.010(C). Council introduced above at its December 3, 2019, meeting. **ORDINANCE** 2019, meeting. ORDINANCE AMENDING WHATCOM COUNTY CODE, 16.30 LAKE WHATCOM STORMWATER UTILITY FUNDING MECHANISM, CHANGING THE DATE FOR COLLECTION OF CAP-ITAL FACILITY CHARGES FROM JANUARY 1, 2020 TO JANUARY 1, 2021 (AB2019-614): This ordi nance amends Ordinance 2019-053, Lake Whatcom Stormwater Utility Funding Mechanism, to initiate the Capital Facilities Charges in January 2021 rather than January 2020. The requested time extension is needed to develop an effective collection process and to clarify ambiguous language included in Section 11 of Whatcom County Code 16.30. Council introduced above at its December 3, 2019, meeting.
