
Electronic Equipment Program Information as of September 30, 2019




- 1. There were 149 unique individuals engaged in electronic monitoring from February, 2018 through September, 2019.
- 2. 67% of the cases have been pretrial and 33% have been post-conviction.
- 3. 75% of the cases have been alcohol and driving related, and 21% have been domestic violence and assault cases.
 - a. Other cases include non-DV stalking, ignition interlock device violations and criminal solicitation.

Electronic Equipment Program Spread Sheet Definitions (Solid line box information is also found in the table)

Month	Specific month for which data is being reported.
Monthly Expense	Amount invoiced and paid
Expense Change From Previous Month	Change in the amount invoiced and paid from one month to the next Clarification: This is based on the Monthly Cost column.
Percent Expense Change From Previous Month	Percent change in the amount and paid from one month to the next. Clarification: This is based on the Monthly Cost and Month to Month \$ Change columns.
Total Defendants On Devices Each Month	The number of unique identified individuals using devices for each month reported. Example: Defendant 1 begins and ends device monitoring in April. This Defendant will be counted as one for the month of April only. Defendant 2 begins device monitoring in April and ends in June are recorded as one in the monthly totals for April, May and June.
Combined Daily Use Of All Devices	The total numbers of days that all devices combined were in use for each month reported. Example: Defendant 1 is put on a device from April 5 th through April 10 th , for a total of six days. Defendant 2 is put on a device from April 3 rd through April 13 th , for a total of eleven days. The total number of days for April is 17. (6+11=17)
Defendants Starting Each Month	The number of unique identified individuals who began electronic device monitoring for each month reported. Example 1: Defendant 1 is put on a device in March and ends in April. Defendant 2 is put on a device in April and ends in May. Defendant 3 is put on a device in April and ends in June. The total new defendants for March are one (defendant 1). The total new defendants for April are two2 (defendants 2 and 3). The total new defendants for May are zero. Example 1, continued: If defendant 1 is put back on a device in June, this person is counted as a new defendant for that month because there was a break in device monitoring.
Defendants Ending Each Month	The number of unique identified individuals who stopped electronic device monitoring for each month reported.
