### COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its March 10, 2020, meeting.

**ORDINANCE (2020-007) AMENDING WHATCOM COUNTY CODE (WCC) 2.150, WHATCOM COUNTY VETERANS' ADVISORY BOARD, AND WCC 2.152, VETERANS' ASSISTANCE PROGRAM (AB2020-092):** This ordinance changes Whatcom County Code 2.150 and 2.152 to reflect the definition of the term "veteran," and to properly place the eligibility guidelines for veterans who are indigent in the County Code. Council introduced this ordinance at its February 25, 2020, meeting.

**EMERGENCY ORDINANCE (2020-008) AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$250,000 (AB2020-131):** This ordinance appropriates \$250,000 in Non Departmental to fund COVID-19 emergency response. As per Whatcom County Code 2.02.135 Emergency Ordinances, necessary for the immediate preservation and of the public peace, health, safety, or support of the county government and its existing institutions may be passed by an affirmative roll-call vote by two-thirds of the entire council.


