COUNCIL ACTION TAKEN The Whatcom County Council adopted the following at its May 19, 2020 meeting: ORDINANCE (2020-023) AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 12, IN THE AMOUNT OF \$77,641 (AB2020-194): This ordinance requests funding from the General Fund to appropriate \$47,016 in Parks to fund Lookout Mountain Road Failure A&E from FEMA grant proceeds, and to appropriate \$30,625 in Parks to fund Point Whitethorn Stairway A&E from FEMA grant proceeds. This ordinance was introduced on May 5, 2020. ORDINANCE (2020-024) AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$250,000 (SUPERSEDES ORD. NO. 2020-008)(AB2020-195): This ordinance requests funding from the General Fund to appropriate \$250,000 in Non-Departmental to fund COVID-19 response. This ordinance was introduced on May 5, 2020.
