

COUNCIL ACTION PROPOSED

The Whatcom County Council will consider adopting and may amend the following at its July 21, 2020, meeting or at a later date:

ORDINANCE AMENDING THE 2019-2020 BUDGET REQUEST NO. 14. (AB2020-276): This ordinance amends the Budget in the amount of \$1,810,500. Included therein: Homeless Housing Fund \$120,000; Conservation Futures Fund \$995,500; Real Estate Excise Tax II Fund \$695,000. This ordinance was introduced on July 7, 2020.

ORDINANCE ESTABLISHING THE SILVER BEACH CREEK FUND AND ESTABLISHING A PROJECT BASED BUDGET FOR THE SILVER BEACH CREEK STORMWATER IMPROVEMENT FUND (AB2020-277): This ordinance establishes a new fund titled Silver Beach Creek Stormwater Improvements Fund Phase 1 of the project will treat runoff from approximately 24 acres, with system upgrades which will remove approximately 15 pounds of phosphorus. This ordinance was introduced on July 7, 2020.
