Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its August 5, 2020, 6 PM meeting, or at a later date:

ORDINANCE REGARDING STALLATION OF STOP SIGNS ON COUNTY CERTAIN ROADS (AB2020-291): This ordinance will correct a scrivener's error Whatcom County Ordinance 1987-009 and allow for the installation to reestablish all-way stop control at Everson Goshen Road and E. Smith Road intersection. During prepara-tions for the E. Smith Road Pavement Rehabilitation Project it was discovered that a scrivener's error existed on Page 7 of Appendix A that is referenced in Ordinance 1987-009. That page listed a stop sign as located at Everson Goshen Road southbound at E. Hemmi Road where it should have been listed as located at Everson Goshen Road southbound at E. Smith Road. Council introduced above at its July 21, 2020 meeting.
