AMENDING WHATCOM COUNTY CODE 16.30 LAKE WHATCOM STORMWATER UTILITY SERVICE AREA REGARDING CLARIFICATION OF REQUIREMENTS OF CAPITAL FACILITIES CHARGES (AB2020-393): This amendment modifies the definition of "Equivalent service unit" (ESU) from the original ordinance for clarification when implanting the regulation. Modifies the definition of "Impervious surface" to be consistent with the current adopted definition within Whatcom County Code. Expands on how the CFC is assessed to single-family residential parcels and other developed parcels. Council introduced the above at its September 29, 2020 meeting.
