Funding Amount & Source

Council approved \$50,000 for painting and \$65,000 for carpeting in the Central Plaza Building in the REET Fund during the mid-biennium budget process (Ord #2019-088, Exhibit "B"). A budget transfer was recently approved by the Executive's Office to reallocate \$22,000 from the paint cost center to the carpet cost center to cover the budget shortfall for this portion of the project.
