ACTION TAKEN

The Whatcom County Council adopted the following at its May 18, 2021, meeting: ORDINANCE (2021-028) AMENDING THE SIX-YEAR (2021-2026) CAPITAL IMPROVEMENT PROGRAM (CIP) FOR WHATCOM COUNTY FACILITIES (AB2021-258). This ordinance amends the Six-Year Capital Improvement Program (CIP) for Whatcom County Facilities (2021-2026) to add the Whatcom Unified Emergency Coordination Center re-roof project to the Six-Year CIP. Ordinance introduced May 4, 2021. **ORDINANCE (2021**the Six-Year CIP. Ordinance introduced May 4, 2021. ORDINANCE [2021-029] IMPOSING AN INTERIM MORATORIUM ON THE ACCEPTANCE AND PROCESSING OF APPLICATIONS AND PERMITS FOR NEW OR EXPANDED FACILITIES IN THE CHERRY POINT URBAN GROWTH AREA, THE PRIMARY PURPOSE OF WHICH WOULD BE THE SHIPMENT OF UNREFINED FOSSIL FUELS NOT TO BE PROCESSED AT CHERRY POINT (AB2021-227). This interim moratorium prohibits the filling, acceptance, and processing of new applications for conversion of land or water, new building or structure permits, or other County permits or authorizations in the Cherry Point Urban Growth Area for new or expanded facilities whose purpose is to facilitate the increased shipment of unrefined fossil fuels not to be processed at Cherry Point, unless the applications: 1. Were filed and complete prior to the effective date of this ordinance and vested pursuant to Washington statutes; 2. Were for building permits for remodels, maintenance, or repairs of existing structures where no increased capacity for shipping unrefined fossil fuels not to be processed at Cherry Point will result; or 3. Were necessary to protect health and safety of the community. This interim ordinance shall be effective for not longer than six months following its effective date, but may be renewed for one or more six-month periods if subsequent public hearings are held and findings of fact are made prior to each renewal. Ordinance introduced April 20, 2021. ORDINANCE (2021-030) AMENDING THE 2021 WHATCOM COUNTY BUDGET, REQUEST NO. 7, IN THE AMOUNT OF \$5,156,985 (AB2021-264). This ordinance amends the 2021 Whatcom County Budget as follows: From the General Fund - appropriate \$28,615 in Sheriff to fund ballistic vests, appropriate \$100,000 in Planning to fund offsite buffer mitigation program feasibility study, appropriate \$2,171,429 in Health to fund mass vaccination site program from DOH FEMA grant proceeds, appropriate \$1,621,652 in Health to fund COVID response efforts from DOH COVID ELC grant proceeds, appropriate \$489,577 in Health to fund staffing for vaccination support activities from DOH grant proceeds; from the Homeless Housing Fund - appropriate \$309,712 to fund additional Emergency Solutions Grant program activities; from the Solid Waste Fund - re-appropriate \$113,000 to fund Comprehensive Solid & Hazardous Waste Management Plan update; from the Conservation Futures Fund - appropriate \$253,000 to fund Kiera-Duffy forestry and ecological conservation easement purchase of development rights; from Real Estate Excise Tax I Fund - appropriate \$70,000 to fund county share of WUECC roof replacement. In addition, Supplemental No. 7 requests the addition of 5 FTE Public Health Nurse positions in Health. Ordinance introduced May 4, 2021.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on June 1, 2021, or at a later date: **ORDINANCE AMENDING THE 2021 WHATCOM COUNTY BUDGET, REQUEST NO. 8, IN THE AMOUNT OF \$1,250,000** (AB2021-289). This ordinance amends the 2021 Whatcom County Budget as follows: From the Conservation Futures Fund – appropriate \$1,250,000 to fund match for Whatcom Land Trust Skookum Creek forest acquisition. Ordinance introduced May 18, 2021.


